- B. NO WARRANTIES ARE MADE WITH RESPECT TO THE SERVICE AND MAINTENANCE PROVIDED UNDER THIS AGREEMENT OR OTHERWISE BY AC GUYS, EXCEPT AS EXPRESSLY STATED IN A WRITING DELIVERED TO YOU BY AC GUYS OR AS MAY BE IMPLIED BY LAW.
- C. No prior present agreements or representations are binding on AC Guys unless expressly stated in this Agreement. No modification to or change in this Agreement is valid or binding on AC Guys unless in writing and executed by AC Guys.
- D. If any litigation arises out of breach, enforcement, interpretation or other action with respect to this Agreement, the prevailing party in such litigation shall be entitled to recover, from the non-prevailing party, reasonable attorney's fees, cost and expenses. Venue for any action arising out of this Agreement shall be in Orange County, Florida.
